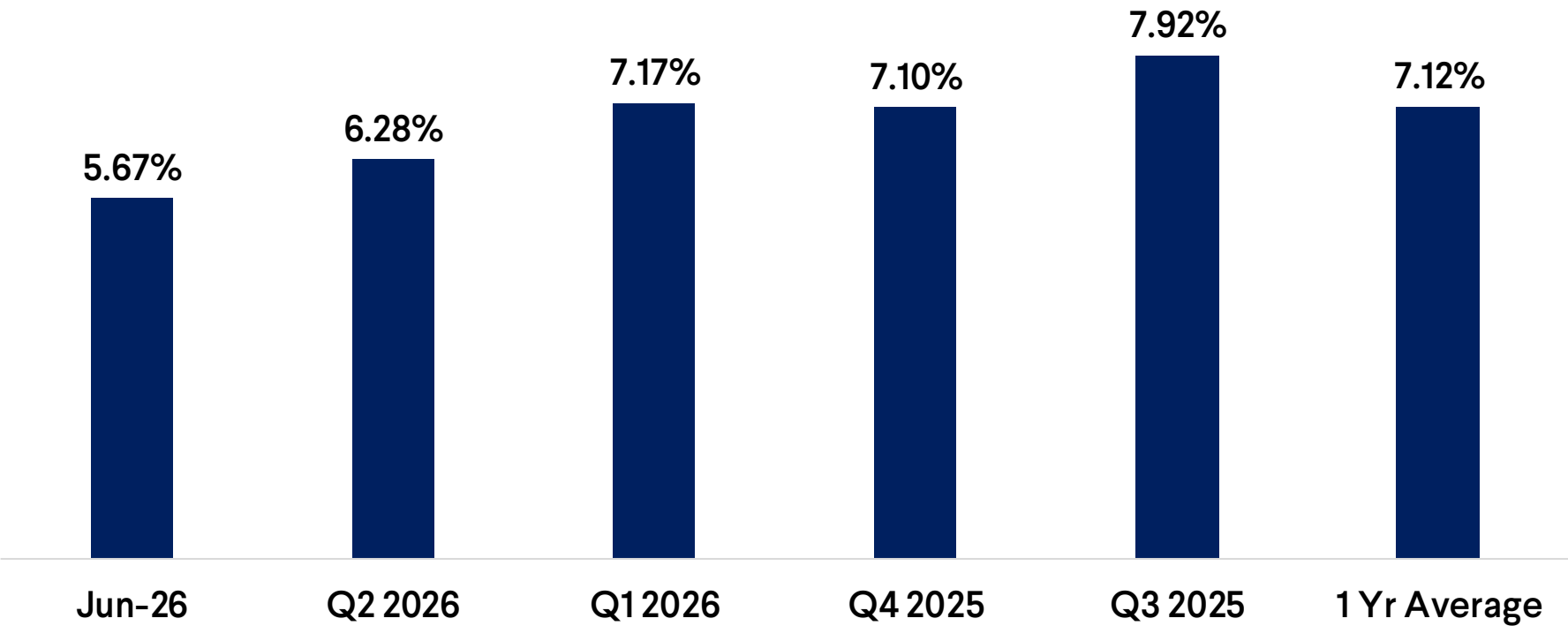

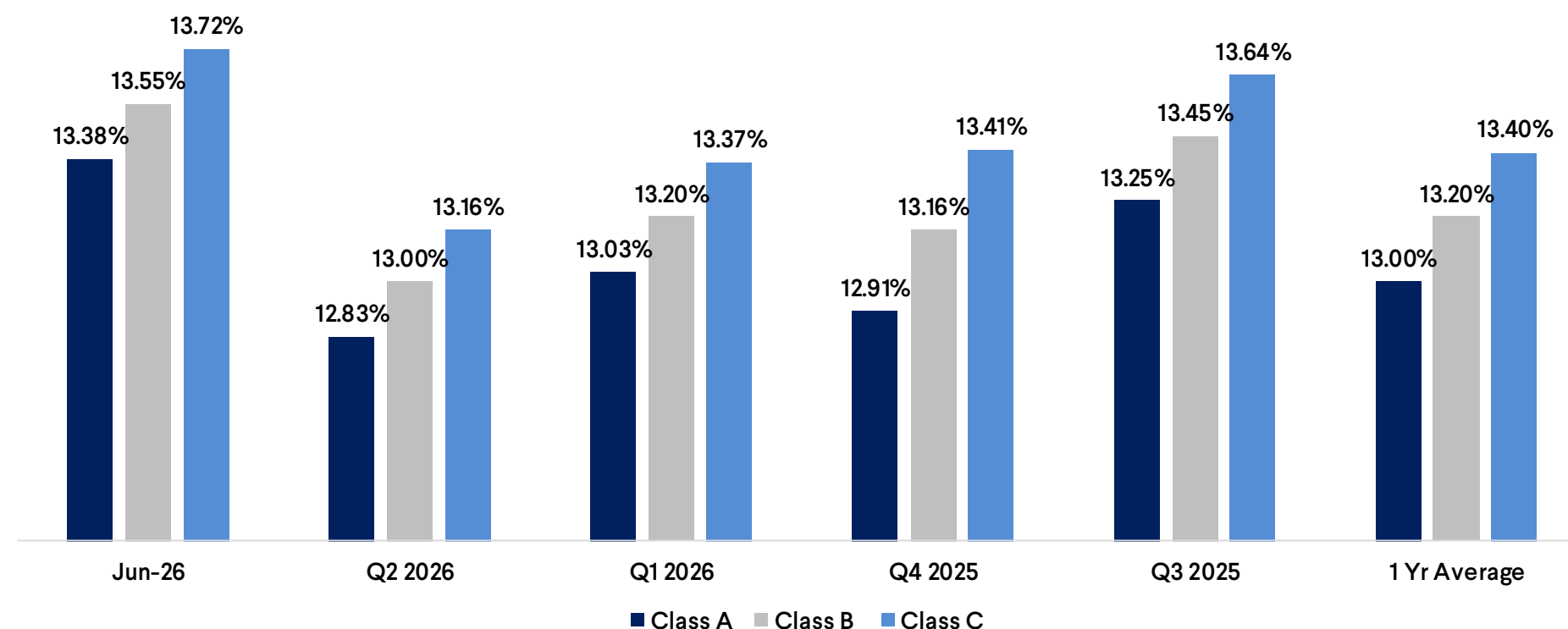

Fund Average Yields (Per Annum)



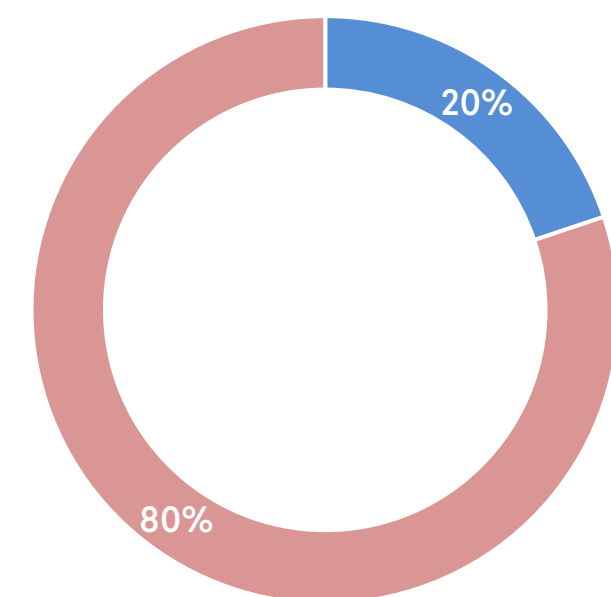
